The High Court in the Official Memorandum under reference 2nd cited has directed the Chief Judge, Puducherry, to impart two months On-the-Job Training to the above said Trainee Civil Judges for the period from 05.10.2015 to 11.12.2015, as per the training schedule given by the Tamil Nadu State Judicial Academy, Chennai.

Now, the Director, Tamil Nadu State Judicial Academy, Chennai, in the letter under reference 3rd cited has stated that the Hon'ble Committee for Tamil Nadu Mediation and Conciliation Centre, High Court, Madras has resolved to conduct 40 hours Mediation training programme for the Referral Judges i.e., the newly appointed Civil Judges (2015 Batch) who are presently undergoing intensive training programme at the Tamil Nadu State Judicial Academy, Chennai, for 5 days i.e., from 14.12.2015 to 18.12.2015 at the Academy itself. The Chief Judge, Puducherry is directed to prepare the schedule of the 'On-the-Job' training programme for the period from 12.12.2015 to 22.12.2015, according to the training needs of the Trainee Civil Judges and is required to provide 'On-the-Job' training to the newly recruited Civil Judges during the extended period i.e., from 12.12.2015 to 22.12.2015.
