

OFFICIAL MEMORANDUM

Sub: Court and Judges – Letter received from the Hon'ble Mr.Justice Madan B.Lokur, Judge, Supreme Court of India, New Delhi requesting to hold Refresher cum advanced Training Programme for existing Ubuntu Linux Master Trainers (Judicial Officers) in various Judicial Academies across the Country – Considered – 28 Judicial Officers nominated (15 already existing Ubuntu Master Trainers and 13 Newly selected Ubuntu Trainers) for training on Ubuntu Operating System and CIS version 2.0 - Scheduled to be conducted at the Tamil Nadu State Judicial Academy, Chennai in Three Batches – (1) I Batch to be conducted from 28.02.2015 to 03.03.2015 (7 Judicial Officers), (2) II Batch to be conducted from 04.03.2015 to 07.03.2015(13 Judicial Officers) and (3) III Batch to be conducted from 08.03.2015 to 11.03.2015 (8 Judicial Officers) – Orders issued.

The Hon'ble Mr.Justice Madan B.Lokur, Judge, Supreme Court of India, New Delhi in **the** letter cited has stated that the Hon'ble E-Committee has now customized the latest version of Ubuntu Linux Operating System that is version 14.04. This is useful softwares, features and functionalities that can be taken advantage of by Judicial Officers and computer using Court Staff. A refresher cum advanced training programme for existing Ubuntu Linux Master Trainers (Judicial officers) is proposed in various Judicial Academies across the Country. It is proposed that the existing Master Trainers (Judicial Officers) will be given this training (including in the new Case Information Software version 2.0) so that they can pass on their learning to other Judicial Officers in the optimum usage of the same.

Further to streamline and augment the change management exercise for Judicial officers and Courts across the Country, the number of Master Trainers (Judicial Officers) is proposed to be increased by inducting fresh talent. This will ensure wider coverage and availability of Master Trainers (Judicial Officers) at all the District Courts. It is proposed to conduct a few batches of these training programmes in the Judicial Academy of each state, His Lordship has requested to facilitate the arrangement of these training programme which will go a long way in promoting the change management exercise for computerization of the Courts and the District Judiciary.
