The Director, Tamil Nadu State Judicial Academy, Chennai in the letter under reference fourth cited has stated that the under mentioned newly appointed Civil Judges are now undergoing 'On-the-Job' training at the District Headquarters, from 28.12.2015 to 04.03.2016, after completion of the Intensive Training Programme at TNSJA, Chennai, from 05.10.2015 to 22.12.2015.

As the newly appointed Civil Judges are going to complete their 'On-the-Job' training at the District Headquarters, on 04.03.2016, the Director, Tamil Nadu State Judicial Academy, Chennai, has requested that the undermentioned newly appointed Civil Judges (2015 batch), who have bar experience upto 4 years may be directed to undergo Further Intensive Training Programme (FITP) at the Tamil Nadu State Judicial Academy, Chennai, for a period of 4 weeks from 07.03.2016 to 02.04.2016, after the completion of the 'On-the-Job' training which they are presently undergoing at the District Headquarters from 28.12.2015 to 04.03.2016.

As ordered, the under mentioned 36 newly appointed Civil Judges of Tamil Nadu State Judicial Service, on completion of their 'On-the-Job' training at District Headquarters, on 04.03.2016, are required to undergo Further Intensive Training Programme (FITP) at the Tamil nadu State Judicial Academy, Chennai, for a period of 4 weeks i.e., from 07.03.2016 to 02.04.2016.

The undermentioned 36 Judicial Officers are required to report before the Director, Tamil Nadu State Judicial Academy, Chennai, on 08.30 a.m., on 07.03.2016, after availing holidays on 05.03.2016 (Saturday) and 06.03.2016 (Sunday), after handing over charge of their respective posts to the nearest District Munsifs / Judicial Magistrates / District Munsif-cum-Judicial Magistrates, as the case may be, on 04.03.2016 A.N.

The Officers who relieve the Trainee Civil Judges on 04.03.2016 A.N., are required to hold full additional charge of the additional posts, till the Trainee Civil Judges take charge of their respective posts after completion of their Further Intensive Training Programme or until further orders, as the case may be.
