- 5) Breakfast, lunch, and dinner, wherever required, will be provided by TNSJA.
- 6) No family members, relatives, friends, or any other person(s), either child or adult, of the judicial officer, shall accompany him/her, to the place of training. Accommodation, food and other arrangements are made only to the officers nominated.

- 7) The officers will be accommodated on double occupancy basis in the rooms at Delhi Judicial Academy, New Delhi. They will, in no circumstance, be permitted to extend their stay, after the programme concludes.
- 8) The officers must take adequate care of their belongings, valuables, cash, etc.
- 9) The officers should not possess/consume alcoholic drinks/tobacco products.
- 10) The officers shall bring with them the medicines, as may be required for them.
