Accommodation will be provided only to those, who confirm the requirement to the Court Managers of their respective Districts.

The nominated Officers from outstations are permitted to claim T.A./D.A. in this regard, as per rules in force.

The aforesaid nominated officers (except Serial Nos 1 to 22) are required to handover charge of their respective posts to the nearest District Munsif / Principal District Munsif / Additional District Munsif / Judicial Magistrate / District Munsif-cum-Judicial Magistrate, as the case may be, before proceeding to attend the programme.

The relieving Officers are required to hold full additional charge of the additional posts during the absence of the said nominated Officers.

The absence of the Officers attending the said programme from the Headquarters / Office in this regard, is treated as on other duty.

The aforesaid nominated Officers are informed that any request for exemption from participating in the said programme will not be entertained.
